【Course Objectives: 授業の到達目標】

International law serves as a common language in international relations and global governance. Its understanding is essential in grasping how the world order has been shaped and is being challenged at the same time. It opens up a valuable horizon for anyone interested in thinking about the world in these turbulent times.

This course aims to equip the participants with the basic concepts of international law covering a wide range of issues. Through the prism of the instructor's experiences in the international legal practice at the International Criminal Tribunal for the former Yugoslavia (ICTY), the International Court of Justice (ICJ) as well as the Ministry of Foreign Affairs of Japan, the course puts a special emphasis on the ability to apply the concepts "in context" through interactive discussions.

【Course Summary: 授業の概要】

This course is open to students across faculties. The most important thing expected of participants is the willingness to actively participate in the classes, as the course will be conducted in an interactive manner.

This course will not only explore basic concepts in international law but will also pay particular attention to how historical, political, economic, cultural and other factors and contexts inform the international law-making and its enforcement.

Prior knowledge of international law will be an asset but is not strictly necessary.

In case of online teaching, we will use live online meeting system. Seminar students are particularly encouraged to take this course.

【Reading assignment】 This course requires a certain amount of reading. (一回の分量は3ページ以内です。) Participants are expected to fully prepare for each session.

【Short presentation】 Participants will prepare short presentations on assigned topics.

【Culture of Integrity Program】 One session will be dedicated to the "Culture of Integrity" program, in which participants are expected to prepare a questionnaire to interview practitioners working in various fields of global governance in different capacities and to participate in active discussions.
